### 3. General characteristics of transaction, type and size of transaction:

#### 3.1 General characteristics of transaction:

KBank has conducted the selling procedure by using bidding process and appointing the independent law company to manage the sale of PL's common shares to PL first 28 major shareholders. KBank has negotiated the selling price with the bidder.

## 3.2 Type and size of transaction:

The transaction size shall be deemed a transaction involving asset or service with value of connected transaction more than 0.03% but lower than 3% of KBank's net tangible asset value as at September 30, 2006. The transaction value equals to 0.13% of KBank's net tangible asset value as at September 30, 2006.

# 4. Total value of transaction:

Number of shares held before the transaction: 35,627,900 shares, corresponding to 7.9639%

Number of shares held after the transaction: 0 shares, corresponding to 0.00 %

Pricing: Not lower than 2.90 Baht per share, 3-month average market price (during September 7, 2006 – December 6, 2006).

KBank's directors who have interest and are connected persons in this transaction are Mr. Banyong Lamsam, Pol.Gen. Pow Sarasin, Mr. Banthoon Lamsam, and Ms. Sujitpan Lamsam, who, during the considering this Agenda, did not attend the meeting and did not vote on the approval for this transaction.
